5. Fire Fighting Measures 消防措施

7. Handling and Storage 操作和贮存

Handling 操作:

- 1. Batteries are designed to be non-recharged. 电池被设计为不可充电的。
- 2. Do not immerse, throw, and wet a battery in water.不浸没、投掷和用水弄湿电池。
- 3. Should a battery unintentionally be crushed, thus releasing its contents, rubber gloves must be used to handle all battery components. Avoid the inhalation of any vapors that may be emitted.如果电池被无意挤压而导致内部物质释放,必须带上橡胶 手套处理所有的电池成分, 避免吸入释放的任何气体。

- Batteries should be separated from other materials and stored in a noncombustible, well ventilated, sprinkler-protected structure with sufficient clearance between walls and battery stacks. Engineering Controls: Keep away from heat and open flame.

Ventilation: Not necessary under conditions of normal use. In case of abuse, use adequate mechanical ventilation (local exhaust) for the battery that vent gas or fumes.
