The test conditions of the circuit breaker configuration quantity are the same as that of the inrush current test. The PC cover, shell and plug for LED driver in the lamps must meet the UL94-V0 and above. Unless otherwise stated, the parameters of the power factor, harmonic and efficiency were test results under the ambient temperature of 25°C, humidity of 50%, input voltage of 230V(50Hz) and full load.
